basic data

- Inhabitants: 2 milion
- Language: Slovenian
- State: since 1991, member of European Union since 2004
- Currency: Euro
- Capital: Ljubljana (350.000 inhabitants)
- Climate:
 - Mediteranian in the West;
 - Alpine in the North
 - Continental in the East

Airport Maribor

technical data

- Built in 1976 – Rebuilt in 1999/2000 – Passengers Terminal in 2007/2008
- Location: North-Eastern Slovenia
 - Maribor city – 9 km; Harbour Koper – 230 km; Vienna – 250 km; Venice – 369 km
- Main airplains area: 460 m x 111 m x 125 m
- Arrival/Departure track: 2400 m x 45 m
- Carrying capacity: PCN 86 F/A/X/T
- Attitude: 261 m – 266 m about sea level
- Parking of airplains: 5 x A-320 / A-310 (15-20 m wings)
- Parking for cars: 580 places + 10 for buses
- Storage warehouse: 4.100 m²

actual data

- ❑ Modern, good equipped airport with one terminal
- ❑ The owner of the airport is the Slovenian State, the owner of the surrounding facilities is Aerodrom MB (SHS Aviation)
- ❑ Capacity without substantial investments about 1 million passengers/year
- ❑ From 2016 Until 2019 rented to SHS Aviation (Chinese company)
- ❑ **In 2018: 2.700 passengers and 234 tons cargo traffic / loss**
- ❑ **Contract between the State and SHS Aviation cancelled in July 2019**
- ❑ **Monthly maintenance costs aprox. 100.000 EUR, rent aprox. 250.000 EUR**
- ❑ **The new manager of the Airport Maribor is DRI Investment Management**
- ❑ **Expected call for investment concession**
- ❑ **TRAININGS OF PILOTS ON THE DAILY BASIS**

Progress of the TNC project in Slovenia

- ❑ The concept of the LEADER TNC project AIR confirmed at the Executive Board and at the Assembly of the LAG Prlekija in May/June 2019
- ❑ Talks with potential national partners in progress (2 Municipalities, University, Chamber of Commerce, Entrepreneurs)
- ❑ TNC project to be financed through EFRD (special rules)
- ❑ Changes of the Local Development Strategy to be confirmed by the National Management Authority) – expected confirmation October/November 2019
- ❑ Letter of intent to be signed in September 2019 by the national partners
- ❑ Start of the TNC project (eligible costs) in January 2020 (kick off)

Open issues

- **At the national level:**
 - Prevent closing of the airport (EU funds)
 - Management of the airport (expected call in 2019)
 - Investment capacities of the new manager (linked to the duration of the rent)
 - Concept of the Airport Maribor
 - Many different expectations and interests about the Airport Maribor

- **At the LEADER/CLLD level:**
 - The CLLD rules in Slovenia do not enable financial transactions between project partners. Only common procurements with clear demarcation of the costs between partners needed
 - Preferable costs are employed human resources
 - Local LAG on the territory of the Airport Maribor is too small to place the project into the LDS (local municipalities support development of the airport)
